This application must be submitted twenty-two (22) days in advance of a regularly scheduled Planning Board meeting together with the following:

- 1. Review Site Plan Review Checklist for required data.
- 2. A description/narrative of the proposed project with sufficient detail to provide the Planning Board with enough information to understand the scope of the proposed project. A list of requests for waivers of the Site Plan Review Regulations (see section X of the Site Plan Review Regulations).
- 3. A list of requests for waivers of the Site Plan Review Regulations (see Section X of the Site Plan Review Regulations and the Site Plan Review Checklist for each regulation. The applicant must address each regulation by either providing requested data or requesting a waiver with justification for each waiver request.
- 4. A list and two sets of mailing labels of the names and addresses of all owners, abutters, applicants, holders of conservation, preservation or agricultural preservation restrictions, and everyone whose professional seal appears on any plan or plat submitted to the Board;
- 5. Four (4) complete sets of final plat of blackline or blueline prints drawn to scale and ten (7) 11"X17" sets of plans including the following;
 - a. Sheet size of 22" x 34" preferred, but a maximum of 24" x 36" allowed.
 - b. Scale appropriate to size of project and consistent throughout.
 - c. Space for the Planning Board Chairperson to sign and date the approved plan.
 - d. The plans shall contain the data and/or information delineated in Section 4.3 of these regulations.
- 6. Application and Notice fees as required by the Site Plan Review Regulations.
 - The Application and Notice Fees are listed in the separate fee schedule posted on the Planning Board page of the Town website.
- 7. Sign off by the Tuftonboro Fire Chief (see form posted on the website).
