 - **Promoting Responsible Forest Management:** Providing information and resources for people who wish to manage their forested land for wildlife, recreation, timber management, etc.
 - **Promoting Bee-friendly Ecosystems:** Educating the community on the need to provide and maintain habitats friendly to bees and other native pollinators.
 - **School Programs:** Providing educational resources and programs for the school; assisting with the butterfly garden.
 - **Composting:** Encourage the practice of composting and develop a town composting site.
 - **Organic and Natural Farming Practices:** Provide information on and encourage the use of organic and natural methods of farming.
