## 4415 Health Agencies

Selectman Albee reviewed the budget and reported that the 2021 request is down from 2020. Selectman Albee went over particular line items that changed from last year and answered questions from the committee. Mr. Theve made a motion to approve the 4415 Health Agencies budget in the amount of \$40,185.00, seconded by Ms. Hartshorn. ### 4210 Police Department

Chief Shagoury reviewed the budget and reported that the 2021 request is up 2.8% from 2020. A majority of this increase is due to salary. It was also noted that the 2020 Conferences & Training expenditure was low from what had been budgeted because of cancellations due to COVID. Chief Shagoury reviewed and discussed line items and answered questions from the committee. Chairman Hunt made a motion to approve the 4210 Police Department budget in the amount of \$441,247.00, seconded by Mr. Theve. A roll call vote followed: Mr. Ennis – Yes; Selectman Albee – Yes; Ms. Hartshorn – Yes; Mr. Theve – Yes; Mr. Chehames – Yes; Chairman Hunt – Yes.

#### 4312 Highway Department

Mr. Bean handed out a packet detailing line items in the Highway Department's budget. Mr. Bean reviewed each line item and answered questions from the committee. In particular, the road preparation and repair were discussed as was seasonal maintenance items. Ms. Hartshorn made a motion to approve the 4312 Highway Department budget in the amount of \$624,325.00, seconded by Mr. Theve.
